**THE HOMA BAY COUNTY SUPPLEMENTARY
APPROPRIATION ACT, 2026**

No. 1 of 2026

Date of Assent: 11th February, 2026

Date of Commencement: 16th February, 2026

AN ACT of the County Assembly of Homa Bay to authorize the issue of certain sums of money out of the County Revenue Fund and their application towards the service of the year ending on 30th June, 2026 and to appropriate those sums for certain public services and purposes

ENACTED by County Assembly of Homa Bay as follows—

PART I—PRELIMINARY PROVISIONS

Short title

1. This Act may be cited as the Homa Bay County Supplementary Appropriation Act, 2026.

Appropriation of money for the requirements of the Homa Bay County Government

2. (1) Appropriation by the County Assembly of money from the county revenue fund for the requirements of the County in respect of the financial year 2025/2026 to votes and the main divisions within a vote and for the purposes that are specified, are set out in the schedules to this Act.

(2) The spending of appropriations envisaged in subsection (1) is subject to the provisions of the appropriations law and the Public Finance Management Act, 2012.

(3) The spending of funds withdrawn from the County Revenue Fund before this Act is enacted into law, as envisaged in section 135 of the Public Finance Management Act, 2012 shall be included in the Supplementary Appropriation Law, under separate votes, for the services for which it is withdrawn.

Issue of funds by the County Treasury

3. (1) The County Treasury may issue the sum of **Kenya Shillings Thirteen Billion, six Hundred and one Million, Four Hundred and Fifty Thousand, Nine Hundred and Sixty-Four** only out of the County Revenue Fund and apply towards the supply granted for the service of the year ending 30th June, 2026.

(2) The sum granted by sub-clause (1) shall be appropriated for the several services and purposes specified in the second column of the First Schedule, in the amounts specified in the third column of that schedule.

(3) In addition to the sum granted by Sub-clause (1), the sum specified in the fourth column of the First and Second Schedules shall be applied for the several services and purposes specified in the second column of those schedules, out of the revenue directed to be applied outside the County Revenue Fund under Article 207(1)(2) of the Constitution.

Amount listed as specifically and exclusively appropriated

4. An amount within a vote or main division within a vote that is listed as specifically and exclusively appropriated in the schedule to this Act may be utilized only for the purposes indicated, unless the amount or purpose for which it was allocated is amended by an act of County Assembly.
