MOBILE NAVAL BASE DEFENCE ORGANISATION.

Approval has already been given to the enlistment and training of the fighting personnel of the R.M.Group (R.M.Secret Circulars No.2000/40.A. of 2.1.40 and 10.2.40.) In order that arrangements may be made to enable complete defences for a base, including under-water defences, to be available, it has now been approved that, as from 15th May 1940, departments concerned are to make provision to enable an advanced Base to be established at one month's notice. Arrangements for the provision of personnel and equipment are to be implemented as follows :-

(a) Personnel.


To be made available as far as possible from existing reserves and margins, any additional personnel required being enlisted and utilised in the margins for meeting other war commitments.

(b) Stores.

Material required, as far as notice permits, should be included in normal holdings, or held on dormant demand. Only material which cannot be available at the required notice is to be specially obtained and held in stock.

2. The appendix, attached sets forth an establishment which is intended to serve as a guide in making administrative arrangements, assessing, earmarking or accumulating material, and earmarking or providing personnel.

3. In order to co-ordinate the work of the various groups of the M.N.B.D.O., and to carry out preliminary planning and administrative work a skeleton Naval Staff consisting of one Captain and one Commander, R.N. and an Accountant Officer is being appointed.
